#### SCOPE OF WORK

Stage, AV services will be provided at The Washington Monuments grounds North East Quadrant.

# Works to be carried out by the Tenderer:

- a) Setup of 28ft x 12ft stage with 4 feet height from the ground level.
- b) Setup of frame for banners to be placed on the stage in size of 10x4(Left), 10x4(Right) and 28ftx4(TOP).
- c) Audio Visual to cover 2 acres of area and sound sufficient for at least 1000 people expected to gather at the venue.
- d) Pickup of all Items to be carried out on the same day after the event.
- e) Setting up of the stage to the satisfaction of the Event officer of the Embassy.
- f) Setting of two LED screens (8ft 5 inch x 14 ft) to show the stage performance live on the screens.
- g) Two Videographer for video shooting of the event and providing 2 minute video of the event within 12 hours after the event.

### **Special Terms and Conditions**

- The Tenderer need to deploy the professional workers/technicians trained and having adequate experience in the field to carry out work in a satisfactory and professional manner. The quality of work should not be compromised.
- If, at any time during the period of contract, it is observed by the Embassy or its authorized representative, that the services rendered by the company are not to the satisfaction of the corporation or any terms of the contract are violated, Embassy reserves the right to terminate the contract without any notice.
- Work will be authorized by means of a Works Order issued under the authority of Embassy of India, Washington DC.
