



The Expressions of Interest (Bid) shall be submitted in a Sealed Cover before 10:00 AM on May 13, 2019 in the office of Head of Chancery, Embassy of India, Washington DC, (2107, Massachusetts Avenue NW, Washington DC 20008). Any bid received after this date and time will not be considered. Bid shall be opened on May 15, 2019 at 03:00 PM.

• The bid shall remain valid for a period of Sixty (60) days from the date of opening or any extended period.

· Bidder shall quote his/her price for booking charge (agency charge) for

booking of hotels /tickets (air & train).

 Bidder shall only charge for booking charge for booking of hotels/tickets, etc., excluding actual charges paid for booking.

Bidder has to provide the Embassy the actual charges paid for booking of

hotels/tickets to concerned service provider for every booking.

 The Embassy of India will not be bound to accept the lowest bid or any tender or to give a reason for the rejection of any tender.

The successful bidder shall be responsible for coordinating his work with

various services provider of this Embassy.

• The Embassy of India will not be responsible to compensate for any expense or losses that may be incurred by the bidder in the preparation and submission of his bid.

Bidder shall not alter the bid Document unless otherwise permitted.

 The amount and rates for variations i.e. booking charge/agency charge, etc., excluding taxes must be quoted both in figures and words in US Dollars only. In case of any discrepancy between figures or words, the amount or rates quoted in words shall be taken to be correct for this tender.

 The acceptance of the bid shall be conditional and not finally binding upon the Employer until the actual contract signed between the bidder/tenderer and the Embassy of India. Should the tenderer fail to sign the contract within the stipulated time or for any other reason withdraw his participation in the tender, the Embassy may withdraw his acceptance of the tender without any notice or other formality and may enter into a new Agreement for the execution of the works. No payment shall be released to the tenderer unless the agreement is signed.

- If any bid is submitted under a name other than the name of the individual firm, partnership or corporation that was issued the bid Document, it will be not be considered by the Embassy.
