- 1.3 While all efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 1.4 The bidder shall submit the copy of the authorization letter / Power of Attorney as the proof of authorization for signing on behalf of the Bidder.
- 1.5 All Bidders are hereby explicitly informed that conditional offers or offers with deviations from the conditions of Contract, the bids not meeting the minimum eligibility criteria, Technical Bids not accompanied by EMD of requisite amount/format, or any other requirements, stipulated in the tender documents are liable to be rejected.

- 1.6 The Parties to the Contract/Agreement shall be the successful bidder (to whom the work has been awarded) and the Client, Embassy of India, Washington DC

2. Scope of Work:

SCOPE OF WORK

Janitorial Services at four buildings located at :-

- 1) 2107 Massachusetts Ave, NW, Washington DC 20008 (on daily basis) (Chancery-I Building)
- 2) 2111 Massachusetts Ave, NW, Washington DC 20008 (on daily basis) (Chancery-I Building)
- 3 2536 Massachusetts Ave, NW, Washington DC 20008 (on daily basis) (Chancery-I I Building)
- 4) 1438 U Street NW, Washington DC 20009 (24 man-hours per month).

Works to be carried out by the Agency.

2(i) Daily

- a. Sweep and damp mop all hard floor surfaces, uncarpeted raised floors and other types of non-waxed flooring. Sweep and mop all interior wood floor surfaces.
- b. Regular cleaning of dust and damp mop whole parking area of all 4 Buildings and passage way area to parking.
- c. Sweep and damp mop of front area of all 4 buildings especially removal of of tree leaves (with blower), mud and snow.
- d. Cleaning of security guard rooms, common hall & kitchen area located at ground & first floor in parking area near Building 1 & 2.
- e. Spot vacuum all rugs and carpeted areas (including carpeted raised floors). Spot sweep or vacuum all internal stairways as required.
- f. Wipe Cleaning of Board Room and Foyer Area twice a day.
- g. Cleaning of Washrooms with disinfectants, maintain hygiene, replenish necessary supplies and removal of trash in Chancery-I and Chancery-II twice a day.
- h. Dust and wipe clean with damp cloth all furniture, file cabinets, equipment and windows, etc.
- i. Dust all chair rails, trim, etc.
- j. Empty and clean all general waste receptacles and remove wastepaper and waste materials to designated areas.
- k. Empty recycling receptacles and remove to designated areas.
- 1. Damp dust interiors of all waste disposal and recycle receptacles.
- m. If necessary, Clean glass furniture tops
- n. If necessary, Brush fabric-covered chairs

- o. Remove finger prints, dirt, smudges, graffiti, etc from the glass door, door frames, glass partitions, light switches, walks, elevator call buttons, elevator door jambs and doors.
- p. Remove finger marks from all painted or vinyl covered surfaces near light switches, entrance doors, etc.
- q. Dust low reach areas (up to 70-inches, but not limited to, structural and built-in furniture ledges, base-boards, windowsills, doors and chairs.
- r. Mop/sweep service stairways and remove all debris and Clean all marble base and tile floor base.
- s. Clean building entrance doors, window panes and lobby glass and keep in a clean condition both from inside and outside.

2(ii) Weekly

- a. Clean and polish glass and plastic desktops and tabletops.
- b. Vacuum all upholstered furniture
- c. Dust curtains / Window Blinds.

2(iii) Monthly

- i. Dust all hard to reach areas not reached in daily dusting but not limited to, all picture frames, charts, graphs, similar wall hangings, walls doors, baseboards, partitions, electrical and light fixtures, vents, ducts and sprinklers.
- ii. Dust all mini-blinds with treated cloth.

2(iv) Cleaning material:

Cleaning materials are to be provided by the service provider. List and quantity of the cleaning material is to be provided along with the financial bids by the service provider after taking the stock of the job at the place of work.

2(v) Manpower required:

5 Janitors are required for 8 hours per day. Payment will be made on monthly basis.

3. MINIMUM ELIGIBILITY CRITERIA

- 3.1 Should be registered / incorporated in the USA.
- 3.2 Should have an experience of at least 3 years in providing commercial cleaning/housekeeping services.
- **3.3** Should have at least one Government premises/Embassy/Diplomatic Organization/MNCs as its clients.
- 3.4 Should not have barred or blacklisted by any organization in the USA, or by Government of India.

4. <u>EARNEST MONEY DEPOSIT</u>

4.1 The Earnest Money Deposit of USD 500/- in the form of account Payee Demand Draft/Pay Order issued by any reputed Bank drawn in favour of "Embassy of India" has to be submitted along with the bid. The validity of the Demand Draft/Pay Order must be up to 6 (six) months from the last date for submission of bids.

- 4.2 No request for transfer of any previous deposit of Earnest Money Deposit or Performance Security Deposit or adjustment against any pending bill held by the Client in respect of any previous work shall be entertained.
- 4.3 Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid security shall be forfeited to the government or will render the bidder ineligible to submit bids for contracts with the Embassy of India, Washington DC
- 4.4 The bids without Earnest Money Deposit will be summarily rejected.
- 4.5 No claim shall lie against the Client in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit i.e. no interest will be payable on EMD.
- **4.6** The bid security may be forfeited:
 - (i) If the bidder withdraws his bid during the period of validity of the bids specified by the bidder in the bid form; or
 - (ii) In case of successful bidder, if the bidder:
 - (a) fails to sign the contract in accordance with the terms of the tender document:
 - (b) fails to furnish required Performance Security Deposit in accordance with the terms of Tender Documents within the time frame specified by the client; or
 - (c) Fails or refuses to honour his own quoted prices for the services or part thereof.

5. VALIDITY OF BIDS

- 5.1 Bids shall remain valid and open for acceptance for a period of 180 days from the last date of submission of Bids.
- 5.2 In case, client calls the bidder for negotiation then this shall not amount to cancellation or withdrawal of original offer which shall be binding on the bidder.
- 5.3 The client may request for extension for another period of 60 days, without any modifications and without giving any reasons thereof.
- PRE-BID MEETING/SITE VISIT: Interested firms/service agencies may visit the site for visualization and better understanding of the quantum of work during August 09 to Sept 03, 2024 after fixing a prior appointment. The bidders may also submit their queries by email on the aforementioned email IDs which will also be discussed in the pre-bid meeting.

6 PREPARATION OF BIDS

- 6.1 <u>Language</u>: Bids and all accompanying documents shall be in <u>English</u> only. The technical as well as the financial bids should be submitted in two sets one original and one copy.
- 6.2 <u>Technical Bid</u>: Technical Bid should be prepared as per the instructions given in the Tender Documents along with all required information, documents in support of the minimum eligibility criteria. All the documents comprising the Technical Bid shall be put in a separate sealed envelope superscribed as "Envelope A Technical Bid". Documents comprising the Bid:
 - a. Technical Bid Submission Form duly signed and printed on Company's letterhead.
 - **b.** Contact Details Form, duly filled and signed & stamped.
 - c. All attested supporting documents in proof of having fully adhered to minimum eligibility criteria as referred in Section-3/Para 3 above.
- 6.3 **Earnest Money Deposit**: Earnest Money Deposit of USD 500/- in the form of account payee Demand Draft or Pay Order or signed copy of Annexure 6 to be submitted separately in a sealed envelope superscribed as "Envelope B Earnest Money Deposit".
- 6.4 <u>Financial Bid</u>: Bidder shall prepare the Financial Bid in the Price Schedule as provided in the Tender Document. Financial Bid shall be put in a separate sealed envelope superscribed as "Envelope C- Financial Bid".

7. SUBMISSION OF BIDS

7.1 The Bidding firms have to submit the tenders in two bid system {i.e (i) Technical Bid and (ii) Financial Bid} in the prescribed proforma. Tenders are to be submitted to 2107 Massachusetts Ave NW, Washington DC 20008. All the documents in support of eligibility criteria etc. and other required documents are to be submitted along with the Tender Documents. No Tender Documents will be accepted after the expiry of stipulated date and time for the purpose under any circumstances whatsoever.

7.2 No Bid shall be accepted after the specified date and time. However, the Competent Authority in the Embassy of India, Washington DC reserves the right to extend the date / time forsubmission of bids, before opening of the Technical Bids.

8. BID OPENING PROCEDURE

8.1 The Technical Bids (Envelope A) shall be opened at 2107 Massachusetts Ave NW Washington DC 20008 in the presence of bidders or their representatives and the Tender

Evaluation Committee constituted by the CompetentAuthority of the Embassy of India, Washington DC. After evaluation of Technical Bids, a list of qualified bidders will be prepared by the Embassy of India, Washington DC. The Financial bids (Envelope 'C') will be opened on a subsequent date, which will be intimated to the shortlisted bidders, by mail/phone.

- 8.2 Bids shall be declared as valid or Invalid based on the preliminary scrutiny, i.e. on site verification of documents submitted by the bidders by the Tender Evaluation Committee. The financial bids will be opened on result of such scrutiny. However, in case any thing found false or forged in contrary to the documents submitted by the bidder, its bid will be rejected and suitable legal action may be taken.
- 8.3 The Financial Bids of only those bidders, who qualify at Technical Bid stage, shall be opened by the Committee authorized for the purpose. Those bidders who qualify in the technical bid stage, will be intimated through mail/phone about the date for opening of the Financial Bids.
- 8.4 The date fixed for opening of bids, if subsequently declared as holiday by the Government, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working date, the time remaining unaltered.
- 8.5 A letter of authorization shall be submitted by the Bidder's representatives before opening of the Bids.
- 8.6 Absence of bidder or their representative shall not impair the legality of the opening procedures.
- 8.7 After opening of the Technical Bids and verifying the EMD amount, the technical bids shall be evaluated to ensure that the bidder meets the minimum eligibility criteria as specified in the Tender Document.

9. CLARIFICATION ON TECHNICAL BID EVALUATION.

- 9.1 The Technical Bids shall be evaluated based on the available documents submitted by the bidder. To assist in the examination, evaluation, and comparison of the bids, and qualification of the bidders, the client may, at its discretion, ask any bidder for a clarification of its bid. Any clarification submitted by a bidder that is not in response to a request by the client shall not be considered. The client's request for clarification and the response shall be in writing.
- 9.2 If a bidder does not provide clarifications of its bid by the date and time set in the client's request for clarification, its bid may be rejected.
- 9.3 Client also reserves the right to seek confirmation/clarification from the issuer agency, on the supporting documents submitted by the bidder.

10. PERFORMANCE SECURITY (PS):

- 10.1 The successful bidder has to deposit Performance Security which will be USD 10% of finalized monthly rate in favour of 'Indian Embassy' in form of Demand Draft / Pay Order/Bank Guarantee within fifteen days of the acceptance of the Letter of Award (LoA). PerformanceSecurity should remain valid for a period of sixty (60) days beyond the date of completion of all contractual obligations of the service provider (SP). In case, the contract is further extended beyond the initial period, the Performance Security will have to be renewed accordingly by the SP. No interest shall be paid on Performance Security.
- 10.2 The Performance Security will be forfeited by order of the Competent Authority in Mission/ Post in the event of any breach or negligence or non-observance of any terms & conditions of the contract or for unsatisfactory performance or for non-acceptance of the work order. On expiry of the contract, portion of the Performance Security, as may be deemed fit by the Client sufficient to cover any incorrect or excess payments made on the bills to the firm, shall be retained until the final audit report on the account of Contractor's billhas been received and examined.
- 10.3 If the Contractor fails to provide the Performance Security within fifteen days of the acceptance of LoA, such failure shall constitute a breach of the contract and the Client shall be free to make other arrangements at the risk, cost and expense of the Contractor.
- 10.4 On due performance and completion of the contract in all respects, the Performance Security will be returned to the SP without any interest on presentation of an absolute 'No Demand Certificate' from the SP and upon return in good condition of any specifications, samples or other property belonging to the client, which may have been issued to the SP, for carrying out work stipulated in the contract.

11. VALIDITY OF CONTRACT

The contract, if awarded, shall be valid for a period of <u>ONE YEAR</u> (01 year). The contract may be extended annually on year to year basis, for further 02 years [maximum tenure 03 years from the date of start of work initially] as per the contract signed on same terms and conditions and same rates, subject to satisfactory services provided by the vendor. In case of breach of contract or in the event of not fulfilling the minimum requirements / statutory requirements, the client shall have the right at any time toterminate the contract forthwith in addition to forfeiting the performance security amount deposited by the Contractor and initiating administrative actions for blacklisting etc. solely at the discretion of the competent authority in Mission/ Post.

12. PAYMENTS

- 12.1 After award of work, a price schedule shall be annexed to the Articles of Agreement according to which all payments shall be made to the SP towards the AMC.
- 12.2 The prices in the Price Schedule shall be inclusive of all applicable taxes as may belevied by the Government from time to time.
- 12.3 All payments shall be made in check by means of crossedcheques/ bank transfer.

- 12.4 The Client shall be entitled to deduct in accordance with applicable law, Income Tax or withholding tax or other deductions (as the case may be), from any payments made to the Contractor, and the amount so deducted shall be deemed to be a payment made to the Contractor.
- 12.5 The payment to the workers in accordance to minimum wages prescribed by the local Government along with the statutory compliance Bonus is sole responsibility of the Contractor. In case of revision in minimum wages by the local Government, the same would be absorbed by the service provider. Claim for any escalation shall not be entertained by the Client.
- 12.6 No request for revision/ increase of approved rates during the currency of the contract will be entertained.
- 12.7 No payment shall be made in advance nor will any loan from any bank or financial institution be recommended on the basis of the order of award of work.

13. Other Conditions, Force Majeure & Penalty Clause

- 13.1 The workers so provided should be on the roll of the Company.
- 13.2 The bidder must have satisfactory arrangements for training of its workers. Confirmation in this regard is to be given.
- 13.3 The bidder should submit precise profile of its key clients along with details of services provided.
- 13.4 If any cleaner is absent on a given day, the company will provide a substitute for him otherwise proportionate deductions will be made from the monthly payment.
- 13.5 In case the Service Provider fails in adhering to the daily cleaning requirements at Mission's/ Post'spremises, and Client has to make alternative arrangements for daily cleaning, then Service Provider would reimburse the cost of such arrangements.
- 13.6 Contractor would be fully responsible for all acts of omission or negligence, dishonesty or misconduct of its employees for work at Mission's/ Post's premises. Contractor would indemnify Client against any compensation/claim and damages etc. due to accident or injury to its employees or death due to accident or otherwise, which may arise out of and during the course of their duties. Client would not be liable to pay any damages or compensation to such cleaners or to any third party.
- 13.7 In case of any complaint, either as regards the nature of service or as regards thebehaviors of cleaners on duty or otherwise, Contractor would be intimated and would be required to take corrective measures promptly.

- 13.8 Client reserves the right to amend/withdraw any of the terms and conditions in the tender documents or to reject any or all tenders without giving anynotice or assigning any reason. The decision of the Client in this regard shall be final and binding on all.
- 13.9 Client reserves its right to revoke the contract at any time, if the services rendered are not found satisfactory during the period of the contract.
- 13.10 Client may, by written notice sent to Housekeeping agency, terminatethe contract, with a notice period of at least one month, in whole or in part at any time for its convenience. The notice of terminationshall specify that termination is for the Client's convenience, the extent to which performance of work under the contract is terminated and the date upon which such termination becomes effective.
- 13.11 The bidder must have modern equipment(s), latest technical expertise for management of buildings and related facilities, as has been defined in brief scope of work. Machinery, equipment, implements, material and consumables proposed to be used should be clearly indicated. List of equipment owned by the company may also be furnished with the bid.
- 13.12 Any wrong or misleading information will lead to disqualification.
- 13.13 The bidder shall maintain at all times machinery / equipment and other resources required for upkeep and cleanliness of the premises of the Client. The SP will arrange at his own cost additional machinery/ equipment and resources if required by the Client for the purpose.
- 13.14 Client reserves the right to remove any person found unfit.
- 13.15 The bidder would be responsible for all mandatory compliance for social, safety and environmental issues related to the performance of the service provider in the Mission's/Post's premises as stated in the eligibility criteria.
